## Financial Aid Policy

The goal of the Athens College of Ministry scholarship program is to assist students in attaining the necessary funds to follow the Lord's calling to attend our institution who would not otherwise be able to attend due to financial constraints.

Need-based scholarships are evaluated on a semester-by-semester basis. Students are also encouraged to develop a ministry team to help support their ministry training program. (Contact the Athens College of Ministry for further information about the development of a ministry team.) Students must be successfully admitted to the college in order to be eligible to apply for a need-based scholarship. Applications for need-based scholarships are due 90 days prior to the first day of class for the semester. Athens College of Ministry students who are attending the institution with the support of a need-based scholarship must:

- Maintain a 90% attendance record for all courses in order to be considered for future need-based funding;
- Maintain an overall academic standing of 3.0; and
- Pay all additional tuition on time for which they are responsible

While the Athens College of Ministry need-based scholarship program is not a loan, graduating students are encouraged to pay forward their financial support package amount to the greatest extent possible after graduation as a way to replenish the scholarship program and to make a way for other students who will take part in the need-based scholarship program.
